

F&N RM188,000 Count & Win Contest

Terms and Conditions

1. The contest period is from 1st October to 31st December 2009.
2. The contest is open to all Malaysians aged 18 and above, except for employees and immediate family members of F&N Dairies (M) Sdn. Bhd., its promotion agencies, advertising agencies, public relations agencies and other parties involved in this promotion.
3. Every two original labels of F&N or Gold Coin Sweetened Condensed Milk or Evaporated Milk of any pack size is eligible for one contest entry.
4. The participating F&N canned milk products are: F&N Sweetened Creamer, F&N Vitaminised, F&N Teh Tarik Sweetened Creamer, F&N Sweetened Condensed Filled Milk, F&N Evaporated Creamer, F&N Evaporated Filled Milk, F&N Evaporated Full Cream Milk, Gold Coin Sweetened Creamer, Gold Coin Sweetened Creamer Kopi Teh Tarik and Gold Coin Evaporated Creamer.
5. Photocopies of entry forms are permitted. Participants may send in as many entries as they wish but each entry must be accompanied by the required proof of purchase.
6. Participants are required to provide an answer to the total number of F&N and Gold Coin labels inside each container. There are 2 containers (container A and container B) as shown in the contest form and each container measures 4 feet in height and 3 feet in diameter.
7. The entry with the exact correct answer will win the Grand Prize. In the event that there is more than one entry with the exact correct answer, the participant with the highest number of entries with the exact correct answer will win the Grand Prize and the participant with the second highest number of entries with the exact correct answer will win the First Prize and so on so forth. In the event of a tie, the participant with the earliest entry received will win.
8. In the event that there is no entry with the exact correct answer, the entry with the lower answer nearest to the exact correct answer will win the Grand Prize

and so forth. If there is a tie for any prizes, the participant with the highest number of entries with the closest answer, follows by the earliest entries will determine the winners respectively.
